HOPE ALLIANCE HELPED ME CHANGE MY LIFE!

I was a 32 year old Mom of a 3 year-old little girl when I entered the shelter at Hope Alliance, which provides nights of safety for the person I was at the time. Three nights earlier, before entering the shelter my husband had chased me down the street with a butcher knife. It is hard to admit, but this was not the first time he had threatened to kill me, nor was it the first time he left me bloody and beaten.

Going to Hope Alliance wasn't the scariest thing I've ever done, but it took more courage than I thought I had because it meant leaving everything behind and starting my life over. Yet, once there, I found that I was surrounded by people whose only purpose was to help me.



They never forced me to make decisions based on what others perceived to be the "right decision." They persistently encouraged me to set and reach goals that they helped me set to recover from my experiences. I was able to live in the safety of the shelter while my Hope Alliance legal advocate helped me obtain an Emergency Protective Order. Hope Alliance's trauma-informed care allowed my daughter and me to safely return to my own home.

I continued to go to counseling offered at Hope Alliance after moving back into my home. Now, because I have met many of my goals, I can actually have hopes and dreams for the future which had been previously beaten out of me. One of those hopes and dreams is that the cycle of violence I experienced ended with me and that my daughter will be able to live a life of love without violence. The help I received at Hope Alliance changed my life and I believe my dream for my daughter will become a reality.
